We are very flexible for our families. We offer aftercare program **until 8pm Monday through Friday** for working families. Our Saturday TI program is also available 9am where we primarily have field trips and arts and crafts. Sundays are also available by appointment only.

Super Star Days

Our after-school care are available during school emergencies, school closures, and all holidays. We have **Super Star Days May through August** with transportation within a 25 mile radius.



🔶 WHAT ARE SUPER STAR DAYS? 🥤

Super Stars days are designated days and times that staff and participants will actively engage in special activities with outside vendors. Our staff and parents will be available to view special events at our Therapeutic Integration (TI) center in Columbia, Maryland.

These days are only offered May through August. All of the special activities and shows are free of charge to our participants and families. Because we opened our doors to Autism Waiver participants and their families in July of 2019, we host anniversary celebrations during the month of July for our families.





The availability of enrollment and participation of the Super Stars days are contingent upon staffing and space of enrollment in our TI center in Columbia. It is encouraged that if a family would like to utilize their TI/Respite Care hours, they should consult our administrator and service coordinator to update their Plan of Care (POC) to indicate that Soaring Stars will be providing services for that participant during our Super Star Days at Soaring Stars Therapy & Learning Center, Inc.

We are currently providing **Intensive Individual Support Services (IISS)** and these hours can also be utilized during the summer in the home and community to offset the TI hours.
